TERMS AND CONDITIONS

The New Member Welcome Bonus and Existing Client Referral Bonus (defined below) are collectively referred to as the "Promotions". The Promotions are administered by BlueShore Financial.

By participating in a Promotion, you acknowledge that you have read, understood, and agree to be bound by these Terms and Conditions.

New Member Welcome Bonus Promotion

The New Member Welcome Bonus Promotion consists of a \$300 cash bonus for:

- a. opening a new personal chequing account at BlueShore Financial; or
- b. opening a new business chequing account at BlueShore Financial

To receive the New Member Welcome Bonus, you must meet all New Member Eligibility Requirements and complete New Member Qualifying Criteria set out below.

New Member Promotion Fulfillment: The New Member Welcome Bonus will be deposited to your BlueShore Eligible Account within 30 business days of you fulfilling the Qualifying Criteria. "Eligible Account" means the personal or business chequing account you hold at BlueShore Financial.

New Member Promotion Limits: Each individual is limited to one New Member Welcome Bonus in their lifetime. For joint accounts, each New Member who has the required number of membership shares (25 shares) and individually satisfies the Qualifying Criteria is eligible to receive the Bonus. Each new client you refer must provide this information at the time of opening their BlueShore account.

Once the new client completes the Qualifying Criteria for the New Member Welcome Bonus set out above, the Existing Member Referral Bonus is also paid.

Referral Bonus Promotion Fulfillment: The Existing Member Referral Bonus will be deposited to your BlueShore Eligible Account (chequing or savings) via electronic funds transfer within 30 business days of BlueShore Financial confirming that the New Member has fulfilled the Qualifying Criteria for their own New Member Welcome Bonus. The Existing Member Referral Bonus is not transferrable or assignable. No substitutions are permitted.

Due to the confidential nature of the membership application and account opening process, you will not be notified of the status of any individual applications of persons referred by you. You will be only be notified when a Referral Bonus is paid to you.

Referring Member Promotion Limits: The maximum Referral Bonus funds that you may receive during your lifetime is \$1,000. Once you have reached this maximum, you will not be entitled to receive any further Member Referral Bonuses for additional Referred Members.
